## 9:10 – 10:10 a.m. Perioperative Management of Cardiac Implantable Electronic Devices (CIEDs)

Jeffrey Luebbert, MD is a Clinical Cardiac Electrophysiologist at the University of Pennsylvania Perleman School of medicine.
