Dr. Sheila Harris, CRNA is a Certified Registered Nurse Anesthetist (CRNA) with over 10 years of experience who specializes in GI Anesthesia and sedation in both in

an inpatient and outpatient setting. She also practices general and regional anesthesia across the age continuum for a variety of cases and procedures. Sheila believes that continual and/or repetitive exposure to GI patients are necessary to identify their unique risks and challenges in order to provide safe and competent anesthesia care. In addition, Sheila acted as Chief CRNA for an outpatient endoscopy center connected with Penn State Health for almost 4 years. She won the Division of Health Sciences Orvis School of Nursing Director's Award. Sheila holds a Doctor of Nursing Practice and a Bachelor of Nursing from the University of Nevada, Reno and a Master of Science in Nursing from Villanova University in partnership with Crozer-Chester Medical Center.

Abdollah Malek, M.D. grew up in Tehran, Iran. He lived as an exchange student in Wahpeton, North Dakota before returning to Iran and graduating from Tehran University School of Medicine in 1976.

Dr. Malek finished his training in general surgery and became board certified as a general surgeon and completed his training and became a board certified plastic surgeon thereafter. He subsequently completed a fellowship in head, neck, reconstructive, and cosmetic surgery at MD Anderson Hospital in Houston, Texas before returning to Wilmington in 1984.

Since then, Dr. Malek has been in practice for plastic and reconstructive surgery and has changed alongside the innovative and technological growth that is forever changing within this field. A significant number of patients are great candidates for non-invasive or minimally invasive surgeries, with smaller or no incisions, allowing short recovery times and very natural results. Many plastic surgeons market that they "specialize" in a specific surgery/area, but Dr. Malek places a strong emphasis on being a variety-skilled surgeon. He performs numerous procedures on multiple parts of the body because he understands that in order to produce natural, harmonious results, one area of the human body always compliments another. This is why being a surgeon specializing in one area, is not always the best solution, and Dr. Malek uses his multi-faceted skills to his advantage by being able to provide more natural, pleasing, and harmonious results.

Lisa Wallace MSN, APRN, FNP-BC Lisa Wallace completed her undergraduate work at Villanova University and then embarked on a twenty-year career in critical care nursing, including ten years as a critical care educator. During this time Lisa was a member of several organization-wide committees at Christiana Care and participated in various performance improvement projects. She was an integral member of the Magnet Education Team that prepared all Christiana Care staff for the organization's first successful Magnet Survey. As a facilitator of Christiana Care Health System's Nurse Retention Committee, she paved a path for the future nursing council system.

Lisa earned her master's degree in the family nurse practitioner tract at University of Delaware in 2009. For the next nine years, Lisa worked as a primary care nurse practitioner for two of Christiana Care Health System's internal medicine offices, serving primarily low-income patients. 




DANA Triple Threat
